In the pitch-black darkness, the President accidentally ran down Mrs. Nathan Lewis, who was crossing the street. A policeman, Stanley Edelin, arrested the chief executive for reckless horsemanship. According to police records, the President simply said, "I am Mr. Pierce," and he was released. The woman suffered little more than minor cuts and bruises.

Twice in 1866, Ulysses Grant, while still Commander of the Army of the Potomac was arrested for speeding. In each case he was fined five dollars in precinct court. While he was President, Grant was racing his buggy west on Madison Street between 11th and 12th Avenues in Washington. Constable William West stepped out into the road and grabbed the horse's bridle. The horse dragged him 50 feet before it stopped. Officer West, a Union veteran, recognized Grant and began to apologize. But the President said, "Officer do your duty." The horse and buggy were taken to police headquarters and briefly impounded – but no charges were pressed because of the confusion over whether of not a President can be arrested without first being impeached by Congress."

For here, in an earlier time Shaolin's soldier-monks invented the martial art of kung fu. Shaolin Monastery did not begin as a center for warlike activities. It was a place for mediation any prayer. According to tradition, an Indian monk named Bodhidharma settled in the area in about 525 A.D. His mission was to teach the form of Buddhism called Zen. From the discipline of Zen mediation sprang a deadly form of combat. This combat is a fast and acrobatic style of self-defense made in the United States by Bruce Lee in the movies and in the television series "Kung Fu." When it was in its heyday, Shaolin Monastery had 2,000 soldier-monks who wielded long sticks and bare fists to defend themselves against bandits and Japanese pirates.

When the Communists came to power in China in the 1940's, they tried to suppress Buddhism. The monastery was damaged in three fires during the 1960's and 1970's. It was then closed by the government. Shi Dauchan, the last true Shaolin master was jailed. Shaolin is once again revered by the Chinese."
