- 1. Determine your eligibility to participate,
- **2.** Complete your registration before deadline (**9am on June 23**<sup>rd</sup>), via the www.policeapp.com portal,
- **3.** Complete on or before the deadline (**5pm on June 23**<sup>rd</sup>), your PES Projected Personality Interpreter (PPI), through the pa.ppi-portal.com, (see detailed notes in the PES section below),
- **4.** Stay up-to-date on exam announcements on the PES website at <a href="https://www.policeexamsolutions.com">www.policeexamsolutions.com</a>.

WPD: Minimum Qualifications  In order to take the entrance exam, a police officer candidate must:	<ul> <li>Possess a high school diploma or G.E.D. certificate; (an Associate's Degree preferred),</li> <li>Possess or have the ability to obtain and maintain a valid Massachusetts driver's license,</li> <li>Possess or have the ability to obtain and maintain an unrestricted Massachusetts Class A License to Carry a Firearm (LTC-A),</li> <li>Be a U.S. Citizen (Birth or naturalization),</li> <li>Be at least 21 years of age on or before the date of the exam,</li> <li>Not be a convicted felon, or have convictions from another jurisdiction that would be treated as a felony in the Commonwealth,</li> <li>Not smoke and stay a non-smoker. Smoking of tobacco products is prohibited as outlined by G.L. c. 41 § 101A of the Massachusetts General Laws,</li> <li>Preferred candidates for this position should have a MCJTC/MPTC full-time certification, or eligible for a full-time police exemption, and</li> <li>Meet all PES exam requirements necessary for your participation.</li> </ul>	
WPD: Additional Qualifications for Eligibility	<ul> <li>A passing grade of 75% and above is required in the written exam,</li> <li>Pass the PAT process,</li> <li>Candidates who pass both the entrance exam and each section of the agility test will move forward in the process,</li> <li>Candidate must pass an extensive background investigation,</li> <li>Candidate must pass psychological and medical examinations, and</li> <li>A final interview with the Chief of Police.</li> </ul>	
WPD: Physical Agility Test (PAT)	BE PREPARED!  The Police Officer Physical Agility Test is a demanding component of the testing process. It is strongly suggested that you train to develop your strength and endurance in order to pass this section of the process.  The Selection Team will identify police officer candidates (using the highest test scores), who will be eligible to take a (PAT) on a later date, TBD Date/Time/Location. The number of candidates moving to this stage will be determined by the Chief of Police depending on potential needs of the department.

PES: Study Guide	At this time, we do not offer a study guide for our exam. The reason being is that unlike other law enforcement entrance exams, our exam is different. It consists primarily of situational and scenario-based questions. For example, it asks questions to better determine who you are and how you would respond in certain situations, how you handle stress, and how you deal with supervisors, to name a few. While there are many study guides on the market which can help you familiarize yourself with "scenario/situational based" question styles, we recommend our candidate's follow these simple steps to exam success:  • Get a good night's sleep the night before the exam,  • Eat a nutritious breakfast before the exam,  • Be Prepared! Have any/all your required documents/materials ready for exam day,  • Know what to bring and what not to bring,  • Be on Time! Check-in starts at 8:15am. Doors close at 9:00am and there is absolutely NO admittance after 9:00am, and  • Answer the test questions honestly.
