General Statement of Job

The City of North Myrtle Beach is now accepting applications for those who are currently South Carolina Certified Class One Police Officers with 3 or more years of certified law enforcement experience. Must be currently certified as a South Carolina Class One Law Enforcement Officer and must become IFSTA Firefighter I certified within one year of hire. All officers certified in other states or those never certified in the State of South Carolina may apply for a non-certified Public Safety Officer position.

This position is eligible for a \$1,000 Sign-On Bonus to be paid to eligible employees according to the following schedule:

- \$300 after completion of new-hire orientation
- \$300 after completion of required training
- \$400 after the employee has successfully completed their probationary period and their performance review meets or exceeds the "Meets Expectation" rating.

Under close supervision exercises responsibilities for the enforcement of state and local laws relating to public safety and welfare. Performs various other public safety activities as required to include fire prevention and suppression. Exercises independent judgment in dealing with dangerous or unusual situations, exercising safety practices and procedures. Works under stressful, high-risk conditions. Acquires and maintains State certification for Police Officer I and Firefighter I. Reports to the on duty Fire or Police Supervisor as required; also reports to the Incident Commander as required by the National Incident Management System.

Physical Requirements

Must be physically able to operate an automobile, police equipment, fire equipment, etc. Must be able to exert up to one hundred pounds of force occasionally, and/or in excess of fifty pounds of force frequently, and/or in excess of twenty pounds of force constantly to move object. Must be able to lift and/or carry weights of ten to one hundred pounds.

Minimum Training and Experience

High school graduate and minimum age 21, good physical condition; possession of all members of both upper and lower extremities; must have vision correctable to 20/20; good character and reputation; possession of a valid South Carolina drivers license. South Carolina Certified Class One Police Officers with 3 or more years of certified law enforcement experience required; fire suppression experience preferred.

- Present a valid birth certificate
- Present a high school diploma or accepted equivalent
- Sign Authorization for Release of Information and meet rigid background investigation:
 - Criminal Background
 - Fingerprint Check
 - Credit Check
 - Past Employment
 - Military Record
 - Other Background
- Pass a Department medical exam
- Possess a valid driver's license. ***NO DRIVING UNDER THE INFLUENCE CONVICTIONS WITHIN THE LAST TEN (10) YEARS.***
- Live within the boundaries of Horry County, South Carolina. Call back and response are requirements of the job.
- Pass a written exam and oral interview board
